Notice Concerning Changes in Operational Scheme of Its Asset (Life & Senior House Kohoku 2)

Advance Residence Investment Corporation (ADR) announced today its decision to change the operational scheme of its asset (S-22 Life & Senior House Kohoku 2) as detailed below.

### 1. Summary of the Changes

### 2. Reason for the Changes

The new MLPM company, HASEKO LIVENET, Inc. is a subsidiary of Haseko Corporation (Haseko), a construction company listed on First Section of the Tokyo Stock Exchange. As of today, HASEKO LIVENET, Inc. manages 39 ADR properties as MLPM.

The tenant and operator of Life & Senior House Kohoku II, Seikatsu Kagaku Un-Ei Co., Ltd. (SKU) has also become Haseko's subsidiary as of November 2013. Haseko has a rich experience, knowhow and track record in managing senior housing asset even before acquiring SKU, through its other subsidiary whose main line of business is management and consulting of senior housing.

By changing the operational scheme, ADR expects that the management and operation of the asset will be maintained and improved and end-tenants satisfaction to improve. Although, there will be no back-up servicer in the new scheme, the operation and management of the asset will continue to be properly monitored by specialist auditor.




