### Notification on Transactions with Interested Parties

Nippon Residential Investment Corporation (NRIC) has found that a business partner of NRIC, Touchstone Residential Management Co., Ltd. (TRM), constitutes an interested party (as defined under the Law concerning Investment Trusts and Investment Corporations; the same hereafter) of the investment trust management company that manages NRIC's assets, Pacific Investment Advisors Corporation (PIA), and accordingly announces as follows.

## 1. Background

Pacific Management Corporation (PMC), which holds more than 50% of the voting rights of all shareholders of PIA, held 33.3% of TRM's shares in the period between February 20, 2006 and December 25, 2006, making TRM an interested party of NRIC during the concerned period.

#### 2. Details of Transactions with NRIC

NRIC has signed into master lease agreements as well as leasing and building management entrustment agreements with TRM for some of the properties owned by NRIC. The subject properties and agreement period are as follows. The required procedures, as pursuant to the Law concerning Investment Trusts and Investment Corporations and related laws and ordinances as well as internal rules, have been performed in executing the concerned agreements.
