Notification on Revision of Investment Unit General Administration Fee Structure

Nippon Residential Investment Corporation (NRIC) announces the agreement reached with Mitsubishi UFJ Trust and Banking Corporation, which undertakes general administration for NRIC (preparing and providing the unitholder register and other administration concerning the unitholder register, administration associated with issue of investment security certificates, etc.), on revising the fee structure for entrustment of the concerned administration. The agreement is outlined as follows.

1. Overview

NRIC has hitherto entrusted the concerned administration to The Mitsubishi Trust and Banking Corporation (presently, Mitsubishi UFJ Trust and Banking Corporation) based on an agreement on entrustment of general administration (administrative agent for investment units) dated August 19, 2005.

October 2005 saw the merger of the former The Mitsubishi Trust and Banking Corporation and former UFJ Trust Bank Limited. In correlation with said merger, Mitsubishi UFJ Trust and Banking Corporation recently decided to shift its investment unit administrative agent system to a new system. In conjunction, the fee structure for the maximum burden of expenses on NRIC will be revised as of October 2007 as set forth in the attached.

2. Outlook

The impact of this change in fee structure on NRIC's management performance is minimal. Accordingly, there is no change to the management performance outlook for the eighth fiscal period (fiscal period ending in November 2007).
