Notice Concerning the De-collateralization

Advance Residence Investment Corporation (ADR) today announced its decision regarding the signing of the de-collateralization agreement between ADR and its lenders on June 15, 2011. As announced in the notice titled "Notice Concerning Debt Financing and Early Repayment of Loans" dated May 17, 2011, ADR has been working to have the collateral released by mid-June.

With the execution of the release, ADR's all outstanding loans will be unsecured and non-guaranteed.
