Notice Concerning Change in Master Lessee and Property Manager

Advance Residence Investment Corporation (ADR) announced today its decision to change the master lessee (ML) and the property manager (PM) as detailed below.

1. Summary of the change

The ML and the PM for a property will be changed as follows on December 1, 2013.

2. Reason for the change

By consolidating the property management of ADR's properties to Itochu Urban Community (IUC) which is the major master lessee and property manager of ADR, it will strengthen the cooperation between ADR and IUC. Furthermore, it will promote greater operational management efficiencies and stronger leasing capabilities, and lead to better revenue-generating potential.

The change announced today follows the above mentioned policy. ADR will continue the consolidation of PM companies according to characteristics of each properties under management and the regional strength of the PM companies to achieve higher operational management quality and efficiencies in the long-term.
